

**CITY OF BAYARD
ORDINANCE 888**

**AN ORDINANCE OF THE CITY OF BAYARD, NEBRASKA, ESTABLISHING
WATER RATES FOR CUSTOMERS OF THE CITY WATER SYSTEM;
PROVIDING AN EFFECTIVE DATE; AND PROVIDING FOR A REPEAL OF
CONFLICTING ORDINANCE**

NOW THEREFORE, be it ordained by the Council of the City of Bayard, in the State of Nebraska, as follows:

SECTION 1: **AMENDMENT** “52.07 Water Rates” of the City of Bayard Municipal Code is hereby *amended* as follows:

BEFORE AMENDMENT

52.07 Water Rates

- A. The following rates and charges are hereby established for customers of the city waterworks system:

<i>Rate</i>	<i>\$1.75 per 1,000 gallons</i>
<i>*Minimum monthly bill shall be at least the following amount depending upon meter size:</i>	
<i>Meter Size</i>	<i>Charge</i>
5/8-inch or 3/4-inch	\$33.00per mo.
1-inch or 1-1/2-inch	\$38.50 per mo.
2-inch	\$61.50per mo.
3-inch or 4-inch	\$99.00per mo.

- B. These rates shall become effective with the October 1, 2024 billing.

AFTER AMENDMENT

52.07 Water Rates

- A. The following rates and charges are hereby established for customers of the city waterworks system:

<i>Rate</i>	<i>\$1.85 per 1,000 gallons</i>
<i>*Minimum monthly bill shall be at least the following amount depending upon meter size:</i>	
<i>Meter Size</i>	<i>Charge</i>
5/8-inch or 3/4-inch	\$35.00per mo.
1-inch or 1-1/2-inch	\$40.00 per mo.
2-inch	\$630.00per mo.
3-inch or 4-inch	\$101.00per mo.

B. These rates shall become effective with the October 1, 2025 billing.

SECTION 3: **EFFECTIVE DATE** This Ordinance shall be in full force and effect from October 1, 2025 and after the required approval and publication according to law.


